ORDINANCE NO. 1147

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, RELATING TO PUBLIC STREETS, ADOPTING AND CLARIFYING SPEED LIMITS ON CERTAIN STREETS WITHIN THE CITY AND PROHIBITING PARKING ON CERTAIN CITY STREETS.

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,
DO ORDAIN AS FOLLOWS:

Section 1. The schedule of speed limits adopted by Section 10.24.060 of the Redmond Municipal Code setting forth maximum speed limits on certain streets within the city is hereby supplemented and revised to establish the following speed limits:

<u>STREET</u>	<u>FROM</u>	<u>TO</u>	<u>MAX SPEED</u>
E. Lake Sammamish Pkwy	Redmond Way	South City Limits	35 mph
166th Avenue NE	Redmond Way	Cleveland Street	30 mph
156th Avenue NE	NE 51st St.	Bellevue-Redmond Rd.	35 mph

Section 2. The schedule of parking restrictions set forth in Section 10.52.180 of the Redmond Municipal Code is hereby supplemented by establishing the following parking restrictions.

<u>STREET</u>	<u>FROM</u>	<u>TO</u>	<u>SIDE</u>	<u>PARKING RESTRICTION</u>
NE 65th St.	East Lake Sammamish Pkwy	176th Ave NE	Both	No parking anytime
NE 67th St.	176th Ave NE	Dead End East	Both	No parking anytime
NE 67th St	176th Ave NE	Dead End West	Both	No parking anytime
176th Ave NE	NE 65th St	NE 70th St.	Both	No parking anytime

Section 3. The Traffic Engineer and Department of Public Works are hereby instructed to effectuate the changes contained in this ordinance and to erect the necessary signs and other notices required in accordance with applicable provisions of the Redmond Municipal Code.


Section 4. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not


