ORDINANCE NO. 1191

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE PERSONNEL ADMINISTRATION MANUAL, 1974 EDITION, APPENDIX IV-6, BY REVISING PAY PLAN C IN ACCORDANCE WITH THE 1984 SUPPLEMENT TO THE 1983-1984 AGREEMENT BETWEEN THE CITY AND THE PUBLIC, PROFESSIONAL & OFFICE-CLERICAL EMPLOYEES AND DRIVERS LOCAL UNION NO. 763 WHICH GRANTS PAY INCREASES EFFECTIVE JANUARY 1, 1984.

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,  
DO ORDAIN AS FOLLOWS:

Section 1. The Personnel Administration Manual, 1974 Edition, Appendix IV-6, is hereby amended by revising the Pay Plan C salaries to the following levels:

Section 2. In accordance with the agreement between the City and the Public, Professional & Office-Clerical Employees and Drivers Local Union No. 763, all increases and rates of pay for employees covered by Pay Plan C shall become effective as of the first day of January, 1984.

Section 3. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5)

days after passage and publication by posting as provided by law.
