ORDINANCE NO. 1195

AN ORDINANCE of the City of Redmond, Washington, authorizing the issuance and sale of local improvement district bond anticipation notes in Local Improvement District No. 83-ST-46 pending the receipt of the proceeds of the local improvement district bonds authorized to be issued by Ordinance No. 1130 and providing for the sale of such bond anticipation notes to Boettcher & Company, Seattle, Washington.

WHEREAS, by Ordinance No. 1130 passed by the City Council and approved by the Mayor on June 7, 1983, the City ordered the improvement of portions of 154th Avenue N.E., N.E. 85th Street Bridge and approaches and N.E. 85th Street, all pursuant to Resolution No. 644 adopted April 19, 1983, and, after a public hearing thereon, established Local Improvement District No. 83-ST-46, provided that payment for the improvement be made by special assessments upon the property in the District payable by the mode of "payment by bonds" and provided for the issuance and sale of local improvement district warrants redeemable by cash and/or by local improvement district bonds; and

WHEREAS, Chapter 216 of the Laws of 1982, Regular Session of the State Legislature, authorized any municipal corporation to borrow money and issue short-term obligations as provided in such Chapter, the proceeds of which may be used for any lawful purpose of the municipal corporation, and which short-term obligations may be issued in anticipation of the sale of local improvement district bonds if the bonds have been authorized by ordinance; and

WHEREAS, the City Council deems it to be in the best interest of the City that the City borrow money and issue its short-term obligation or obligations in the form of one or more local improvement district bond anticipation notes for the purpose of providing the funds with which to pay the cost of carrying out

the improvements ordered in Local Improvement District No. 83-ST-46; and

WHEREAS, Boettcher & Company, Seattle, Washington, has submitted an offer to purchase such short-term bond anticipation notes on the terms and conditions hereinafter set forth; NOW THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN as follows:

Section 1. For the purpose of paying the cost of carrying out the improvements ordered in Local Improvement District No. 83-ST-46, local improvement district bond anticipation notes of the District (the "Notes") shall be issued in the aggregate principal amount of \$3,200,000. The Notes shall be numbered from 1 upward; shall be in the denomination of \$5,000 each or any integral multiple thereof; shall be dated June 20, 1984; shall mature on June 20, 1985; and shall bear interest at the rate of 8.75% per annum, payable at maturity, with full obligation on the part of the City to pay interest at the same rate from and after maturity until the Notes with interest are paid in full or until sufficient money for such payment in full is on deposit in the "Local Improvement Fund, District No. 83-ST-46," created by Ordinance No. 1130, and the Notes have been duly called for redemption by the City Treasurer-Comptroller's giving written notice to Boettcher & Company, Seattle, Washington, of such call at least ten days prior to the call date. The Notes shall not be subject to redemption prior to their maturity date. Both principal of and interest on the Notes shall be payable solely out of the "Local Improvement Fund, District No. 83-ST-46," from the proceeds of local improvement district bonds authorized to be issued by Ordinance No. 1130 or other short-term obligations, which the City covenants to use its best

efforts to issue, to be deposited in such fund and/or prepaid special benefit assessments deposited in such fund, and from the Local Improvement Guaranty Fund of the City, and shall be payable in lawful money of the United States of America at the office of the City Treasurer-Comptroller in Redmond, Washington. The City Council declares and finds that the fixing of the above interest rate is in the best interests of the City.

Section 2. The Notes shall be printed or lithographed on good bond paper or may be in typewritten or multicopied form in a form consistent with this ordinance and state law. The Notes shall be signed by the facsimile signature of the Mayor and the manual signature of the City Clerk and shall have a facsimile reproduction of the seal of the City printed thereon.

Section 3. The City covenants that it will spend the principal proceeds of the Notes with due diligence to completion of the purposes specified in this ordinance and will make no use of the proceeds of the Notes or other funds of the City at any time during the term of the Notes which will cause the Notes to be arbitrage obligations within the meaning of Section 103(c) of the United States Internal Revenue Code of 1954, as amended, and the applicable regulations promulgated thereunder.

Section 4. Boettcher & Company, Seattle, Washington, has submitted an offer to purchase the Notes at a price of par! ^{+ .05%} the *DM* City to furnish the printed, typewritten or multicopied Notes and the approving legal opinion of Roberts & Shefelman, municipal bond counsel of Seattle, Washington, at the City's expense. Bond counsel shall not be required to review or express any opinion concerning the completeness or accuracy of any official statement, offering circular or other sales material issued or used in connection with the Notes, and bond counsel's opinion shall so state. The City Council, deeming that it is in the

best interest of the City that such offer be accepted, accepts the same. The Notes, therefore, shall be delivered to Boettcher & Company, Seattle, Washington, immediately upon their execution upon payment therefor in accordance with such offer.

The principal proceeds received from the sale of the Notes shall be paid into the "Local Improvement Fund, District No. 83-ST-46," and used to pay the costs of the improvements ordered to be carried out by Ordinance No. 1130.

Section 5. This ordinance shall take effect from and after its passage and five days following its publication or posting as required by law.
