ORDINANCE NO. 1197

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE PERSONNEL ADMINISTRATION MANUAL, 1974 EDITION, APPENDIX IV-8 BY REVISING SALARY PLAN D IN ACCORDANCE WITH AGREEMENTS BETWEEN THE CITY AND THE REDMOND FIREFIGHTERS UNION #2829 IAFF EFFECTIVE JULY 1, 1984.

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON DO ORDAIN AS FOLLOWS:

SECTION 1. The Personnel Administration Manual, 1974 Edition, Appendix IV-8, is hereby amended by revising the salary levels listed in Salary Plan D as set forth in Exhibit A, attached hereto and incorporated herein by this reference as if set forth in full.

SECTION 2. The effective date of this amendment to the Personnel Administration Manual, 1974 Edition, set forth in this ordinance shall be July 1, 1984. This ordinance shall be in full force and effective five (5) days after passage and publication by posting as provided by law.
