

ORDINANCE NO. 1207

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON,
AMENDING THE PERSONNEL ADMINISTRATION MANUAL, 1974
EDITION, APPENDIX IV-11, BY AMENDING SALARY PLAN E,
EFFECTIVE SEPTEMBER 8, 1984.

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN
AS FOLLOWS:

Section 1. The Personnel Administration Manual, 1974 Edition,
Appendix IV-11, Salary Plan E, is hereby amended by revising the salary
levels listed in grades 70E through 79E as set forth in Exhibit A
attached hereto and incorporated herein by this reference as if set forth
in full.

Section 2. The changes to Salary Plan E effectuated by this
ordinance shall be effective as of September 8, 1984.

Section 3. This ordinance, being an exercise of a power specif-
ically delegated to the City legislative body, is not subject to referendum,
and shall take effect five (5) days after passage and publication as
provided by law.
