ORDINANCE NO: 1252

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE PERSONNEL ADMINISTRATION MANUAL 1974 EDITION, APPENDIX IV-3 AND APPENDIX IV-5A BY REVISING SALARY PLAN A-1 AND SALARY PLAN B-1 EFFECTIVE JANUARY 1, 1985 AND JANUARY 1, 1986.

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The Personnel Administration Manual, 1974 Edition, Appendix IV-3, Salary Plan A-1 is hereby amended as set forth in Appendix "A" and "C" attached hereto and incorporated herein by this reference as if set forth in full.

Section 2. The Personnel Administration Manual, 1974 Edition, Appendix IV-5A, Salary Plan B-1 is hereby amended as set forth in Appendix "B" and "D", attached hereto and incorporated herein by this reference as if set forth in full.

Section 3. The changes to Salary Plan A-1 and Salary Plan B-1 effectuated by this ordinance shall be effective as of January 1, 1985 and effective January 1, 1986 accordingly.

Section 4. This ordinance, being an exercise of power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication by posting as provided by law.
