ORDINANCE NO. 1290

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE 1985 BUDGET ADOPTED BY ORDINANCE NO. 1220, TO PROVIDE FOR UNANTICIPATED EXPENSES.

WHEREAS, the City is required by applicable state law to finalize its annual budget prior to the commencement of the fiscal year, and

WHEREAS, the amounts of required expenditures can only be estimated at the time of finalization of said budget resulting in the need to amend the budget from time to time to provide for unanticipated required expenditures, which could not have been reasonably foreseen at the time of adoption of the budget, and

WHEREAS, upon the recommendation of the Finance Department, the City Council has determined that certain adjustments should be made to the 1985 budget, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The final budget for the fiscal year 1985 as adopted by Ordinance No. 1220, passed by the City Council on December 11, 1984, is hereby amended by increasing authorized expenditures from the funds identified on Exhibit A hereto, incorporated herein by this reference in the amounts shown thereon, to fund cost of living wage increases, approved by the City Council.

Section 2. The final budget for the fiscal year 1985 as adopted by Ordinance No. 1220, passed by the City Council on December 11, 1984, is hereby amended by increasing authorized expenditures from the funds identified on Exhibit B hereto, incorporated herein by this reference in the amounts shown thereon, to adjust for expenses incurred in whole or in part in 1984 but paid in 1985, and expenditures authorized for 1984 but made in 1985, to be paid out of 1984 encumbrance reserve funds carried forward into the 1985 budget.

Section 3. This ordinance, being an ordinance appropriating funds, is exempt from initiative and referendum, and shall take effect five (5) days after passage and publication as provided by law.


