ORDINANCE NO: 1301

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE PERSONNEL ADMINISTRATION MANUAL 1974 EDITION, APPENDIX IV-7 BY REVISING PAY PLAN C-1 EFFECTIVE JANUARY 1, 1985 .

WHEREAS, the City of Redmond and the Redmond Police Officers Association representing the Police Support Bargaining Unit has entered into a collective bargaining agreement for 1985 which includes an adjustment of dispatcher salaries and inclusion of other police support personnel salaries in Pay Plan C-1, and such adjustments should be reflected by a change to the City's Personnel Administration Manual, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The Personnel Administration Manual, 1974 Edition, Appendix IV-7, Pay Plan C-1 is hereby amended by adjusting the salaries of dispatchers and by including police support personnel to Pay Plan C-1 and establishing their salaries as indicated at the following levels:
