ORDINANCE NO: 1305

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE PERSONNEL ADMINISTRATION MANUAL 1974 EDITION, APPENDIX IV BY REVISING PAY PLAN C EFFECTIVE JANUARY 1, 1985 .

WHEREAS, the City of Redmond and the Redmond Police Officers Association representing the Police Officers and Sergeants has entered into a collective bargaining agreement for 1985 which includes an adjustment of salaries in Pay Plan C, and such adjustments should be reflected by a change to the City's Personnel Administration Manual, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The Personnel Administration Manual, 1974 Edition, Appendix IV, Pay Plan C is hereby amended by establishing the salaries of Police Officers and Sergeants as indicated at the following levels:
