AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE PERSONNEL ADMINISTRATION MANUAL 1974 EDITION, APPENDIX IV BY REVISING PAY PLAN C EFFECTIVE JANUARY 1, 1986.

WHEREAS, the City of Redmond and the Redmond Police Officers Association has entered into a collective bargaining agreement for 1986 which includes an adjustment of police officer salaries, and such adjustments should be reflected by a change to the City's Personnel Administration Manual, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO
ORDAIN AS FOLLOWS:

Section 1. The Personnel Administration Manual, 1974 Edition, Appendix IV -6, Pay Plan C is hereby amended by adjusting the salaries of Police Officers and Police Sergeants to the following levels, effective January 1, 1986:
