ORIGINAL

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE PERSONNEL ADMINISTRATION MANUAL 1974 EDITION, APPENDIX IV-7 BY REVISING PAY PLAN C-1 AND SETTING OTHER WAGE RATES EFFECTIVE JANUARY 1, 1986 .

WHEREAS, the City of Redmond and the Redmond Police Officers Association representing the Police Support Bargaining Unit has entered into a collective bargaining agreement for 1986 which includes an adjustment salaries for Communications Dispatchers, Office Assistants, and Crime Analyst/Evidence Technician and such adjustments should be reflected by a change to the City's Personnel Administration Manual, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The Personnel Administration Manual, 1974 Edition, Appendix IV, Pay Plan C-1 is hereby amended by adjusting the salaries of Communications Dispatchers and Office Assistants, to the following levels effective January 1, 1986:

Section 2. Effective January 1, 1986, Pay Plan G, Grade 10, shall be adopted for the Crime Analyst/Evidence Technician. At that time the incumbent shall be placed at the following step: Robert Shupe - Step B.

Section 3. The Personnel Administration Manual, 1974 Edition, Appendix IV, Pay Plan C-1 is hereby amended by adjusting the salaries of Communications Dispatcher to the following levels, effective July 1, 1986:

Section 4. Effective July 1, 1986 Pay Plan G, Grade 5 shall be adopted for the Office Assistants in the RPOA Police Support Bargaining Unit. At that time incumbent employees shall be placed in the following steps: Phyllis Blower - Step B, Judith Gibson - Step A, and Dana Barnes - Step A*.

Section 5. This ordinance, being an administrative action, is not subject to referendum and shall take effect five (5) days after its publication, or publication of a summary thereof, in the City's official newspaper.
