ORDINANCE NO. 1378

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, ESTABLISHING AN ARTS ACTIVITY FUND AND AMENDING THE 1987 BUDGET TO AUTHORIZE EXPENDITURES FROM THE NEWLY CREATED FUND.

WHEREAS, by Ordinance No. 1368, adopted by the City Council on April 7, 1987, a Redmond Arts Commission was established and by adoption of the 1987 budget, \$12,000.00 has been budgeted for activities supporting the fine and performing arts, and

WHEREAS, an appropriate fund should be created to facilitate budgeting and accounting of expenditures in support of the arts, now, therefore,

THE REDMOND CITY COUNCIL HEREBY ORDAINS AS FOLLOWS:

Section 1. A new Chapter 3.74 entitled "Arts Activity Fund" is hereby added to the Redmond Municipal Code to read as follows:

3.74.010 Fund Created. A special fund to be known as the "Arts Activity Fund" is hereby established for the purpose of receiving deposits for the purposes set forth in this Chapter.

3.74.020 Purposes - Expenditures. Expenditures shall be made for the conduct and support of public programs which will afford greater local opportunities to experience and enjoy the fine and performing arts and for funding operating expenses of the Redmond Arts Commission

3.74.030 Unexpended Funds. Any unexpended funds remaining in the Arts Activity Fund at the end of any budget year shall not be transferred to the General Fund or otherwise lapse, rather said unexpended funds shall be carried forward from year to year until expended for the purposes set forth in Section 3.74.020, unless otherwise directed by ordinance of the City Council.

Section 2. The 1987 budget, and Exhibit A to Ordinance No. 1348 adopting the 1987 budget, passed by the City Council on November 18, 1986, are each hereby amended by transferring the sum of \$12,000.00 from the Revenue Sharing Fund No. 199 to the Arts Activity Fund No. 111 and correspondingly adjusting the appropriations for each of said funds, as reflected on Exhibit 1, attached hereto and incorporated herein by this reference as if set forth in full.

Section 3. The 1987 budget, and Exhibit A to Ordinance No. 1348, are each hereby further amended to reflect unanticipated revenues in the amount of \$1,500.00 resulting from a grant in the amount of \$1,000.00 and a \$500.00 donation, each to be used for arts activities, which funds shall be shown as revenues to, and appropriations from, the Arts Activity Fund No. 111, also as reflected on Exhibit 1 attached hereto.

Section 4. This ordinance, being an administrative action, is not subject to referendum and shall take effect five (5) days after publication.
