ORDINANCE NO. 1422

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON,
FORMING A BUSINESS IMPROVEMENT AREA PURSUANT TO
RCW 35.87A, TO BE KNOWN AS THE REDMOND DOWNTOWN
BUSINESS IMPROVEMENT AREA.

WHEREAS, on April 19, 1988, the City Council adopted Resolution No. 770 entitled "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, EXPRESSING THE INTENT TO FORM A BUSINESS IMPROVEMENT AREA PURSUANT TO RCW CHAPTER 35.87A AND GIVING NOTICE OF A PUBLIC HEARING UPON THE MATTER", and

WHEREAS, the City Council conducted a public hearing in the City Council chambers on Tuesday, May 3, 1988, at approximately 8:00 p.m., for the purpose of considering public testimony regarding formation of the Business Improvement Area, and

WHEREAS, at the conclusion of said hearing, the City Council has determined that the proposed Business Improvement Area should be formed, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,
HEREBY ORDAINS AS FOLLOWS:

Section 1. A business improvement area should be, and is hereby established pursuant to RCW 35.87A.090 and Redmond City Council Resolution No. 770, to be known as the Redmond Downtown Business Improvement Area.

Section 2. The boundaries of the Redmond Downtown Business Improvement Area shall be as set forth on the legal description attached hereto as Exhibit A, and incorporated herein by this reference as if set forth in full. A common description of the boundaries and a map of the improvement area are set forth in the petition for formation of the Area, a copy of which is on file with the City Clerk.

Section 3. All businesses located within the boundaries of the Business Improvement Area shall be subject to

special assessments authorized by RCW 35.87A.010. Annual assessments are hereby imposed upon all businesses within the Improvement Area except those expressly exempt as stated in the petition. Such special assessments, with a breakdown by classification of business is set forth in the petition attached hereto. Said assessments shall be due and payable to the City Finance Department on or before June 1, 1988, and on or before June 1 of each following year until revised or eliminated by the City Council, pursuant to RCW 35.87A.

Section 4. The uses to which the special assessment revenue shall be put are those authorized by RCW 35.87A.030 which are stated in the initiation petition attached hereto.

Section 5. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication.



LEGAL DESCRIPTION

Downtown Redmond Business Improvement Area

That portion of the South one-half of Section 35, Township 26 North, Range 5 East, W.M. lying Southeasterly of the Puget Power Transmission Line Southeasterly right-of-way line and lying Westerly of the Redmond-Woodinville Road Easterly right-of-way line.

And together with that portion of the East one-half of Section 2, Township 25 North, Range 5 East, W.M. lying Easterly of the Sammamish River Trail Easterly right-of-way line and lying Southwesterly of the Redmond-Woodinville Road Northeasterly right-of-way line.

And together with that portion of the Northeast one-quarter of Section 11, Township 25 North, Range 5 East, W.M. lying Easterly and Northeasterly of the Sammamish River Trail Easterly and Northeasterly right-of-way lines and lying Northwesterly of the Leary Way Northeast Southeasterly right-of-way line and lying Northeasterly of the Burlington Northern Railway Southwestern right-of-way line.

And together with that portion of the Northwest one-quarter of Section 12, Township 25 North, range 5 East, W.M. lying Northeasterly of the Burlington Northern Railway Southwesterly right-of-way line, except the North 621 feet of the West, 195 feet of the East, 485 feet thereof and except the North 460 feet of the East 290 feet thereof.

And together with the following described parcel:

Commencing at the West line of the Southeast one-quarter of the Northwest one-quarter of section 12, township 25 North, Range 5 East, W.M. and the Southwesterly right-of-way line of the Burlington Northern Railway; thence South 69°08'18" East along said Southwesterly right-of-way line, a distance of 699.85 feet to the TRUE POINT OF BEGINNING; thence continue South 69°08'18" East along said Southwesterly right-of-way line, a distance of 400.00 feet; thence South 20°51'42" West, a distance of 181.79 feet; thence North 69°08'18" West, parallel with said Southwesterly right-of-way line, a distance of 408.73 feet; thence North 23°36'42" East, a distance of 182.00 feet to the TRUE POINT OF BEGINNING.

And together with that portion of the Northeast one-quarter of Section 12, township 25 North, range 5 East, W.M. lying Northeasterly of the Burlington Northern Railway Southwesterly right-of-way line and lying Westerly of Bear Creek and lying Southeasterly of the Avondale Way northeast Southeasterly right-of-way line.

And together with King County Assessor's Tax Lot No. 64 in said Northeast one-quarter.

And together with the Southwest one-quarter of the Southwest one-quarter of Section 1, Township 25 North, Range 5 East, W.M. except the North 500 feet of the East 200 feet thereof.

And together with the South 200 feet of the East 1000 feet of the West 1100 feet of the Northwest one-quarter of the Southwest one-quarter of Section 1, Township 25 North, Range 5 East, W.M.

And together with the South 400 feet of the West 100 feet of the Northwest one-quarter of the Southwest one-quarter of Section 1, Township 25 North, Range 5 East, W.M.

And together with the South 900 feet of the West 300 feet of the Southeast one-quarter of the Southwest one-quarter of Section 1, Township 25 North, Range 5 East, W.M.

We, the operators of businesses located within the proposed area, hereby petition the City of Redmond to establish a Business Improvement Area as authorized by RCW Chapter 35.87A within the boundaries described as follows:

Starting at the intersection of Leary Way and the east shore of the Sammamish River, proceed NE along Leary Way to the Burlington Northern Railroad tracks (BNRR), turn east and follow the BNRR tracks to Bear Creek (including the parcel presently occupied by "PriceSetter"). At Bear Creek, turn north and follow Bear Creek to Union Hill Road, turn east and proceed to Avondale Way, turn south and proceed to 170th NE, turn north and proceed to NE 80th St., turn west and proceed to 169th Ave NE, turn north and proceed to a point in line with the extension of NE 83rd St, turn west and proceed along the extension of NE 83rd St to the intersection of NE 83rd St and 167th Ave NE. Proceed north on 167th NE to NE 85th St, turn west and proceed to NE 87th St where 164th becomes known as the Redmond-Woodinville Rd. Continue north on the Redmond-Woodinville Rd to the right of way of the Puget Power line. Only those businesses located on the west side of the Redmond-Woodinville Road are included in the BIA. At the Puget Power Transmission line turn southwest and follow the transmission line to the intersection with the Sammamish River. At the Sammamish River, turn south and follow the river's east shore back to the intersection with Leary Way. See legal description and map attached.

To assist trade and the general economic climate of our business area, the City would levy special assessments upon businesses within the area; deposit the funds in a Special City Fund; and pass them on to the Redmond Downtown Association, who shall expend them only for activities that benefit our area, as outlined in the following paragraphs:

- 1) The City of Redmond would levy special annual assessments by applying the following rates against gross square footage of each business in the area, by category, for the purpose of operating a Business Improvement Area. Categories of businesses are defined in Attachment A.
 - a. All retail space shall be assessed at the rate of \$.20 per square foot annually.
 - b. All service space shall be assessed at the rate of \$.15 per square foot annually.
 - c. All professional service space shall be assessed at the rate of \$.10 per square foot annually.
 - d. All manufacturing/wholesale space shall be assessed at the rate of \$.05 per square foot annually.

These assessments would provide an estimated first year budget of \$162,000. It is estimated that the annual projects undertaken will require complete expenditure of each year's revenues.

2. A minimum and maximum rate shall be established for each category of business.

a. Retail: Total assessment upon any single business shall not exceed \$3,000 (three thousand dollars) annually. A minimum assessment of \$200 (two hundred dollars) will be applied to every retail business within the boundaries.

b. Service: Total assessment upon any single business shall not exceed \$2,500 (two thousand five hundred dollars) annually. A minimum assessment of \$150 (one hundred fifty dollars) will be applied to every service business within the boundaries.

c. Professional: Total assessment upon any single business within the area shall not exceed \$2,000 (two thousand dollars) annually. A minimum assessment of \$100 (one hundred dollars) will be applied to every professional business within the boundaries.

d. Manufacturing/Wholesale: Total assessment upon any single business within the area shall not exceed \$1,000 (one thousand dollars) annually. A minimum assessment of \$50 (fifty dollars) will be applied to every manufacturing/wholesale business within the boundaries.

3. The following organizations would be exempt:

Organizations qualified for charitable contributions under the United States Internal Revenue Code (26 USC 170 c), as well as schools, religious agencies, and sponsors of concessionaires at public events, and vendors or entertainers in area streets and parks who engage in business in the area less than 30 days a year.

4. Uses of revenue and projects undertaken should come within the general scope of decorating public places; promoting public events; providing maintenance and security for common public places; the acquisition, construction or maintenance of parking facilities for the area; providing for professional management and planning; advertising and promotion of retail trade activities; and any and all other activities as defined in RCW Chapter 35.87A.

5. The City of Redmond will contract with the Redmond Downtown Association to be responsible for carrying out the above mentioned activities financed through the special assessments. The Redmond Downtown Association may contract with other agencies for such activities as marketing and promotion but shall not be relieved of its responsibilities.

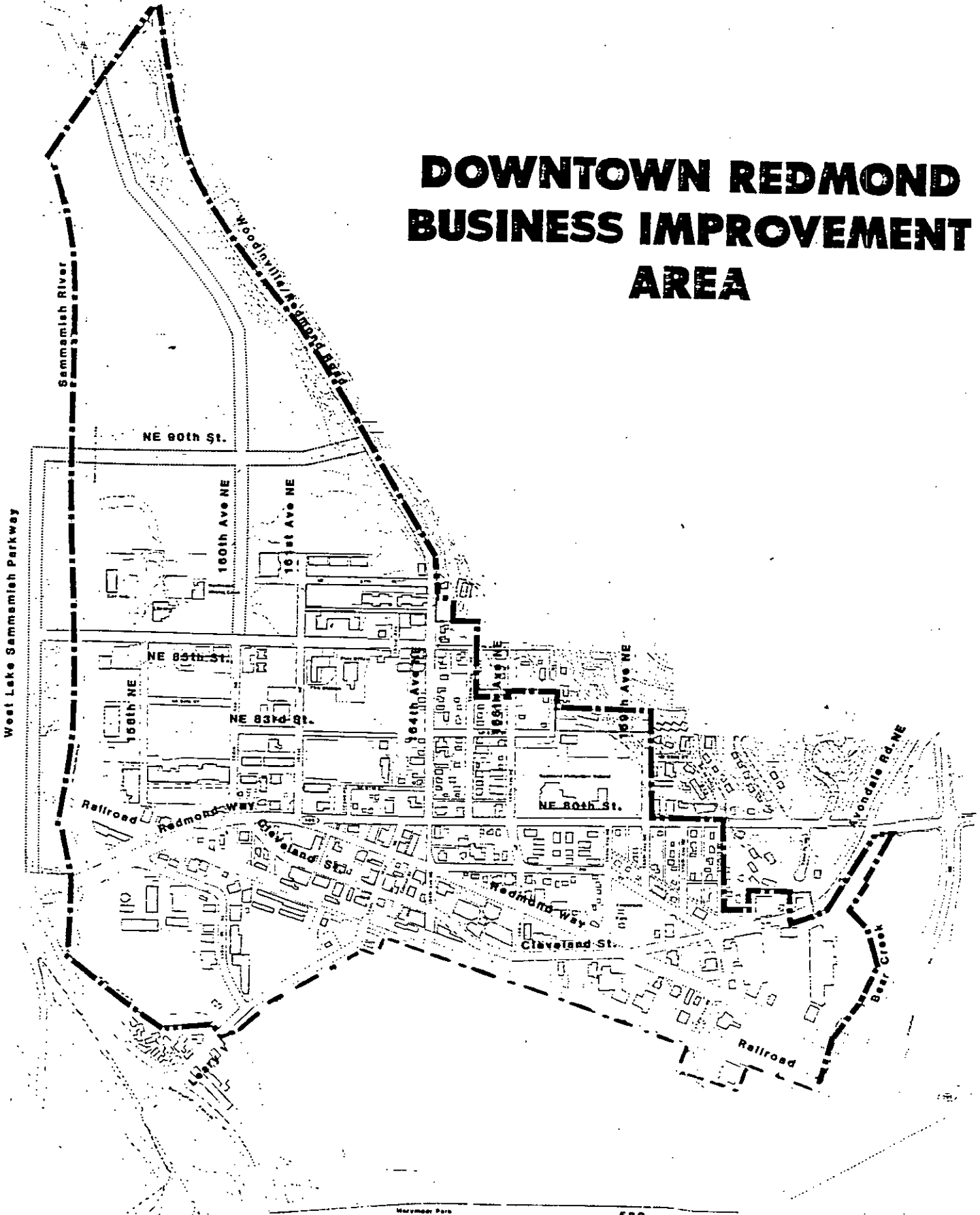




