ORDINANCE NO. 1435

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON,
MAKING ADJUSTMENTS TO CITY BUDGETS,
AMENDING ORDINANCE 1398, 1407 and 1419

WHEREAS, the Finance Director has identified the need to make certain revisions to the 1988 City budget, and the City Council has reviewed the proposed adjustments and has determined that they should be made, now, therefore

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,
HEREBY ORDAINS AS FOLLOWS:

Ordinance No. 1398 adopting the 1988 budget, passed by the City Council on December 8, 1987 and as amended by Ordinance 1407 and Ordinance 1419, is hereby amended by revising Exhibit A to said ordinance, to reflect the increased appropriations set forth in Exhibit I attached hereto and incorporated herein by this reference as if set forth in full. The source of funds for the increased appropriations is cash on hand and investigative fund confiscations.

This ordinance being an administrative action, is not subject to referendum and shall take effect five (5) days after publication.
