ORDINANCE NO. 1461

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, RELATING TO LOCAL IMPROVEMENT DISTRICT NO. 85-ST-48, AMENDING RESOLUTION NO. 777 AND ORDINANCE NO. 1449 TO CORRECT THE REFERENCE TO THE ORDINANCE AMENDING THE DESCRIPTION OF LID IMPROVEMENTS.

WHEREAS, on August 2, 1988, the City Council passed Resolution No. 777, concerning revision of the boundaries of Local Improvement District No. 85-ST-48 and establishing a date and time for a public hearing to consider such revision and the final LID assessment roll; and

WHEREAS, on September 20, 1988, the City Council adopted Ordinance No. 1449, approving and confirming the final assessments and assessment roll of Local Improvement District No. 85-ST-48; and

WHEREAS, both Resolution No. 777 and Ordinance No. 1449 refer to the ordinance amending the description of the LID improvements as "Ordinance No. 1340", when in fact the correct Ordinance No. is 1341, and it is appropriate that this error be corrected; now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY ORDAINS AS FOLLOWS:

Section 1. Resolution No. 777, passed by the City Council on August 2, 1988, is hereby amended by revising Section 1 thereof to read as follows:

Section 1. It is the intention of the City Council to consider amending Ordinance No. 1253, passed by the City Council on June 4, 1985, as previously amended by Ordinance No. 1341, passed by the City Council on October 7, 1986, by revising the boundaries of LID 85-ST-48 to include all property specially benefited by the improvements. The proposed boundaries of the LID, as so revised, are set forth and described in Exhibit A, attached hereto and incorporated herein by this reference as if set forth in full.

Section 2. Ordinance No. 1449, passed by the City Council on September 20, 1988, is hereby amended to revise Section 1 thereof to read as follows:

Section 1. The assessments and assessment roll of Local Improvement District No. 85-ST-48, which has been created and established for the purpose of paying the cost of improvements to street and utility improvements along 180th Avenue N.E. and 178th Place N.E. and related improvements specifically described in Ordinances 1253 and 1341 are hereby in all respects approved and confirmed.

Section 3. This ordinance, being an administrative action, is not subject to referendum, and shall take effect five (5) days after passage and publication as required by law.
