ORDINANCE NO. 1470

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, ORDERING THE IMPROVEMENT OF CERTAIN PROPERTY WITHIN THE CITY; ESTABLISHING LOCAL IMPROVEMENT DISTRICT NO. 87-ST-50; PROVIDING THAT PAYMENT OF A PORTION OF THE COSTS OF THE IMPROVEMENT BE MADE BY SPECIAL ASSESSMENTS UPON THE PROPERTY IN THE DISTRICT, PAYABLE THROUGH ISSUANCE OF LID BONDS; AND PROVIDING FOR THE ISSUANCE AND SALE OF LOCAL IMPROVEMENT DISTRICT WARRANTS OR OTHER SHORT TERM OBLIGATIONS REDEEMABLE IN CASH AND LOCAL IMPROVEMENT DISTRICT BONDS.

WHEREAS, a petition for formation of a local improvement district has been filed with the City proposing the extension of 148th Avenue N.E. north of Redmond Way, which was signed by the owners aggregating a majority of the area within the proposed district as shown by the records in the office of the Auditor of King County (Office of Records and Elections), and which sets forth the nature and territorial extent of the proposed improvement and the mode of payment of the costs of the improvement, all of which is located within the City of Redmond, Washington, and

WHEREAS, the Department of Public Works has determined that the petition is sufficient and that the facts set forth therein are true, and

WHEREAS, the City Engineer caused an estimate to be made of the cost and expense of the proposed improvement and certified that estimate to the City Council, together with all papers and information in his possession touching the proposed improvement, a description of the boundaries of the proposed Local Improvement District ("the District"), and a statement of what portion of the cost and expense of the improvement should be borne by the property within the proposed District, and

WHEREAS, that estimate is accompanied by a diagram of the proposed improvement showing thereon the lots, tracts, parcels of land, and other property and improvements and the estimated cost and expense thereof to be borne by each lot, tract and parcel of land or other property, and

WHEREAS, the City Council has determined it to be in the best interests of the City and of the owners of the property within the local improvement district that said improvement petitioned for, as hereinafter described, be carried out and that the District be created in connection therewith, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY ORDAINS AS FOLLOWS:

Section 1. The City Council of the City of Redmond, Washington, orders the improvement of the following described streets and avenues within the City of Redmond, Washington:

148th Avenue N.E. Extension:

Construct a 52 foot to 68 foot wide street within existing City owned right-of-way and necessary easements, including:

Asphalt paved street with a minimum of 4 through-traffic lanes;

Center turn lane where necessary with left turning pockets at 148th/Redmond Way and N.E. 90th and Willows Road intersections;

Concrete curb, gutter and sidewalks-sidewalk only on the west side of the bridge;

A 60 foot wide pile supported concrete bulbtee bridge 500' long to span an area of unstable soils;

Other improvements:

- storm drainage
- retaining walls
- street trees
- underground power and utilities
- street illumination and channelization
- reconstruct driveways
- install new traffic signal at N.E. 90th Street and Willows Road
- reconstruct traffic signal at 148th and Redmond Way
- install new railroad crossing signal
- realignment of intersections at N.E. 90th Street and Willows Road and at 148th Avenue N.E. and Redmond Way for safety and to improve traffic operations
- install new railroad crossing signal.

All of the foregoing shall be in accordance with the plans and specifications therefor prepared by and/or under the direction of the City Engineer, which may be modified as determined necessary by the City Engineer as long as such modification does not affect the purpose of the improvement.

Section 2. There is created and established a local improvement district, to be called Local Improvement District No. 87-ST-50 of the City of Redmond, Washington ("the District"), the boundaries and territorial extent of which are more particularly described on Exhibit A, a copy of which is attached hereto and incorporated in full by this reference.

Section 3. The total estimated cost and expense of the improvement is declared to be \$4,700,000. A portion of the entire cost and expense of the improvement including all labor and materials required to make a complete improvement, all engineering, surveying, inspection, ascertaining ownership of the lots or parcels of land included in the assessment district, and all advertising, mailing and publication of notices, accounting, administrative, printing, legal, interest and other expenses incidental thereto, shall be borne by and assessed against the property specially benefited by such improvement included in the District embracing as nearly as practicable all property specially benefited by such improvement.

Section 4. In accordance with the provisions of RCW 35.44.047, the City may use any method or combination of methods to compute assessments which may be deemed to fairly reflect the special benefits to the properties being assessed.

Section 5. Local improvement district warrants ("LID Warrants") may be issued in payment of the cost and expense of the improvement herein ordered to be assessed, such warrants to be paid out of the Local Improvement Fund, District No. 87-ST-50, hereinafter created and referred to as the Local Improvement Fund, and, until the bonds referred to in this section are issued and delivered to the purchaser thereof, to bear interest from the date thereof at a rate to be established hereafter by the City Finance Director, as issuing officer, and to be redeemed in cash and/or by local improvement district bonds herein authorized to be issued. In the alternative, the City hereafter may provide by ordinance for the issuance of other short-term obligations ("Short-Term Obligations") pursuant to Chapter 39.50 RCW in payment of the cost and expense of the improvement herein ordered to be assessed.

The City is also authorized to issue local improvement district bonds ("LID Bonds") for the District which shall bear interest at a rate, and to be payable on or before a date, to be hereafter fixed by ordinance. The LID Bonds may be issued (a) in payment of the costs and expense of the improvement herein ordered to be assessed, or (b) in exchange for and/or redemption of any and all LID Warrants issued hereunder or other Short-Term Obligations hereafter authorized and not redeemed in cash within twenty days after the expiration of the thirty-day period for the cash payment of assessments without interest on the assessment roll for the District. The LID Bonds shall be redeemed by the collection of special assessments to be levied and assessed against the property within the District, payable in annual installments, with interest at a rate to be hereafter fixed by the ordinance authorizing issuance and sale of the LID The exact form, amount, date, interest rate and Bonds. denominations of such LID Bonds shall be hereafter fixed by ordinance of the City Council. Such LID Bonds shall be sold in such manner as the City Council shall hereafter determine.

Section 6. In all cases where the work necessary to be done in connection with the making of said improvement is carried out pursuant to contract upon competitive bids, the call for bids shall include a statement that payment for such work will be made in cash warrants drawn upon the Local Improvement Fund

Section 7. There is created and established in the office of the City Finance Director for the District the Local Improvement Fund, District No. 87-ST-50, into which fund shall be deposited the proceeds from the sale of LID Warrants, Short-Term Obligations or LID Bonds which may be issued and sold by the City and collections pertaining to assessments, and against which fund shall be issued cash warrants to the contractor or contractors in payment for the work to be done by them in connection with the improvement, and against which fund cash warrants shall be issued in payment for all other items of expense in connection with the improvement.

Within fifteen (15) days of the passage of Section 8. this ordinance there shall be filed with the City Finance Director the title of the improvement and District number, a copy of the diagram or print showing the boundaries of the District and the preliminary assessment roll or abstract of such roll showing thereon the lots, tracts and parcels of land that will be specially benefited thereby and the estimated cost and expense of such improvement to be borne by each lot, tract or parcel of The City Finance Director shall immediately post the proposed assessment roll upon his index of local improvement assessments against the properties affected by the improvement.

This ordinance shall be in full force and Section 9. effect five (5) days after its passage and publication as provided by law.
