Extension of Sno-King Garbage Company Franchise for two months.

ORDINANCE NO. 1478

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, GRANTING AN EXTENSION OF THE EXCLUSIVE FRANCHISE TO THE SNO-KING GARBAGE COMPANY FOR THE OPERATION OF A GARBAGE AND REFUSE COLLECTION AND REMOVAL BUSINESS IN THE CITY OF REDMOND.

WHEREAS, Ordinance No. 1251 of the City of Redmond grants an exclusive franchise to the Sno-King Garbage Company for the operation of a garbage and refuse collection and removal business in the City of Redmond, and

WHEREAS, the provisions of Section 1. of Ordinance No. 1251 provide for the automatic expiration of that exclusive franchise on March 31, 1989, and

WHEREAS, The garbage and refuse collection and removal services provided by Sno-King Garbage Company under the provisions of that exclusive franchise have met the needs of the residents of the City of Redmond to a degree which has prompted the City of Redmond to begin negotiations with Sno-King Garbage Company for the renewal of that exclusive franchise, and

WHEREAS, The City of Redmond will be seeking the inclusion of provisions in the renewed franchise which will support the application of recycling and waste reduction efforts to the City of Redmond's waste stream, and

WHEREAS, The necessary planning and negotiations for these and other provisions of the renewed franchise cannot be completed by the March 31, 1989 expiration date and garbage and refuse collection services to the residents of Redmond need to be maintained while negotiations for the franchise renewal are concluded, and

WHEREAS, The City Council of the City of Redmond finds the maintenance of uninterrupted garbage and refuse collection services to the residents of the City as provided by the following franchise extension would be in the best interest of the public health, safety and general welfare, and the conditions thereof have been passed more than (5) five days after its introduction, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Franchise Extended - Provisions. The exclusive franchise granted by ORDINANCE NO. 1251 to the Sno-King Garbage Company for the operation of a garbage and refuse collection and removal business in the City of Redmond is extended beyond the automatic termination date of March 31, 1989 provided in Section 1 of ORDINANCE NO. 1251. All provisions of all sections of ORDINANCE NO. 1251 are continued in full with the sole exception of the automatic termination date of Section 1.

Section 2. Term of Extension. The term of this extension shall be until May 31, 1989 or the adoption of an ORDINANCE OF THE CITY OF REDMOND, WASHINGTON which renews the exclusive franchise for the operation of a garbage and refuse collection and removal business in the City of Redmond, whichever comes first, at which time this extension shall automatically expire.

Franchisee shall signify acceptance of the Effective Date. Section 3. terms of this Extension and Ordinance 1251 by signing the original ordinance and/or by operating a garbage and refuse collection and removal business in Redmond. This ordinance shall be in full force and effect five (5) days after passage and publication by posting as provided by law.
