

ORDINANCE NO. 1486AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, MAKING
ADJUSTMENTS TO CITY BUDGETS, AMENDING ORDINANCES 1460, 1465, AND
1475

WHEREAS, the Finance Director has identified the need to make certain revisions to the 1989 City budget, and the City Council has reviewed the proposed adjustments and has determined that they should be made, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY
ORDAINS AS FOLLOWS:

Section 1. Ordinance No. 1460 adopting the 1989 budget, passed by the City Council on November 29, 1988, and as amended by Ordinance No. 1465 and Ordinance No. 1475, is hereby amended by revising Exhibit A of Ordinance No. 1460, to reflect the increased appropriations set forth in Exhibit 1 attached hereto and incorporated herein by this reference as if set forth in full. The source of funds for the increased appropriations is 1988 and 1989 excess revenues.

Section 2. This ordinance being an administrative action, is not subject to referendum and shall take effect five (5) days after passage and publication of the attached summary which is hereby approved.
