## ORDINANCE NO. 1488

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING SECTION 13.16.020 OF THE REDMOND MUNICIPAL CODE TO INCREASE THE AMOUNT OF THE COMMODITY CHARGE FOR WATER SERVICE IN ORDER TO REFLECT AN INCREASE IN THE COST OF WATER PURCHASED BY THE CITY AND TO PROVIDE FOR THE PROGRESSIVE INCREASE OF WATER RATES FOR THE YEARS 1989, 1990 AND 1991, AND REPEALING SECTIONS 2 AND 3 OF ORDINANCE NO. 1450.

WHEREAS, Ordinance No. 1450 of the City of Redmond, passed by the City Council on October 4, 1988, provided for successive amendments of Section 13.16.020 of the Redmond Municipal Code in order to provide for progressive increases in water rates for the years 1989, 1990, and 1991, and

WHEREAS, the City of Redmond purchases some of its water from the City of Bellevue and the Rose Hill Water District, who in turn purchase water from the City of Seattle, and

WHEREAS, the City of Seattle has increased its charge for water to Bellevue and the Rose Hill Water District and Bellevue and the Rose Hill Water District have notified the City of Redmond that this increase will be passed on to Redmond, and

WHEREAS, it is necessary for the City of Redmond to be reimbursed by its customers for this increased cost of water and the City Council has determined that the increase is properly reflected in the commodity charge for water service, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY ORDAINS AS FOLLOWS:

Section 1. 1989 Rates. Effective June 1, 1989, Section 13.16.020 of the Redmond Municipal Code shall be amended to read as follows:

13.16.020 Water Rates Established. For the purpose of fixing rates and charges for the furnishing of water and water service by the City, the following monthly metered rates based upon meter size and water consumption are established:

(B) Apartments, Motels and Mobile Home Parks. Rates shall be the same as the basic commercial rates.

(2) Outside City Limits. Outside the corporate limits of the City, the above rates shall apply, plus a surcharge of 25% thereof.

(3) Senior Citizens Rates. Any customer who provides proof to the City that he or she is 65 years of age or older shall receive a 20% discount off total water charges for service to the residence he or she owns and occupies.

Section 2. 1990 Rates. Effective January 1, 1990,

Section 13.16.020 of the Redmond Municipal Code shall be amended to read as follows:

(1) Multiple Units.

(A) Duplexes and Condominiums. Duplexes and condominiums that have separate meters for each unit will be billed at residential rates. All others will be billed at commercial rates.

(B) Apartments, Motels and Mobile Home Parks. Rates shall be the same as the basic commercial rates.

(2) Outside City Limits. Outside the corporate limits of the City, the above rates shall apply, plus a surcharge of 25% thereof.

(3) Senior Citizens Rates. Any customer who provides proof to the City that he or she is 65 years of age or older shall receive a 20% discount off total water charges for service to the residence he or she owns and occupies.

Section 4. Repealer. Sections 2 and 3 of Ordinance No. 1450, passed by the City Council on October 4, 1988 are hereby repealed.

Section 5. Severability If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 6. Effective Date. This ordinance, being the exercise of a power specifically delegated to the legislative body, is not subject to referendum, and shall take effect and be in force five (5) days after publication of the attached summary, which is hereby approved, provided, that the amendments to Section 13.16.020 set forth in Sections 1, 2 and 3 of this Ordinance, and the rates specified herein shall take effect as follows:

- A. The rates set forth in Section 1 shall be charged for all service for which a billing statement is mailed to the customer on or after June 1, 1989;
- B. The rates set forth in Section 2 shall be charged for all service for which a billing statement is mailed to the customer on or after January 1, 1990; and
- C. The rates set forth in Section 3 shall be charged for all service for which a billing statement is mailed to the customer on or after January 1, 1991.
