

TOWN OF REDMOND, WASHINGTON

ORDINANCE NO. 171

AN ORDINANCE confirming the Assessment Roll for the construction of a sidewalk on the south side of Kirkland street from Union street to Adair street and on the east side of Adair street from the south line of Kirkland street to the north line of Jackson street as provided by Resolution No. 62 passed the 23d, day of September, 1953.


BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF REDMOND, WASHINGTON, as follows:

Section 1. The Assessment Roll for the construction of a concrete sidewalk on the south side of Kirkland street from Union street to Adair street and on the east side of Adair street from the south line of Kirkland street to the north line of Jackson street, pursuant to Resolution NO. 62 passed on the 23d day of September, 1953. now on file in the office of the Clerk of the Town of Redmond, Washington, and the assessments contained therein and leading up thereto, to which no objections have been made or filed by any person, are all in accordance with the laws of the State of Washington and the resolutions and ordinances of the Town of Redmond, and the same, and each and every part thereof, are hereby approved and confirmed, and the tracts and parcels of land described therein as being assessed for said improvement are hereby declared to be specially benefitted thereby to the extent of the assessments respectively assessed against them in said assessment Roll and said tracts and parcels of land are hereby assessed the amount charged against the same as therein set forth and specified.

Section 2. The full amount of the assessment shall be paid in one payment within thirty days after the filing with the Town Treasurer for collection of the final Assessment Roll as confirmed, and the Town Clerk is hereby directed to forthwith file said final Assessment Roll as confirmed with the Town Treasurer for collection. The Town Treasurer shall thereupon publish in the official newspaper of the Town, in two consecutive weekly issues thereof, a notice that the said assessment Roll is in his hands for collection and that full payment of the assessments thereon must be made within thirty days after the date of the filing of said Roll with said Treasurer or the same shall become delinquent.

Section 3. The amount of the assessments as shown on said Assessment Roll shall become a lien against the property described therein from the date of the filing of such assessment Roll with the Town Treasurer. Whenever any payment on any assessment ~~is~~ is delinquent and unpaid for a period of thirty days or more the lien may be foreclosed in the same manner and with the same effect as is provided by chapters 35.43 to 35.54, inclusive, of the Revised code of Washington.

PASSED by the Town Council at a regular meeting thereof and APPROVED by the Mayor this 13<sup>th</sup> day of December, 1954.
