

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN TERRITORY TO THE TOWN OF REDMOND AND INCORPORATING THE SAME WITHIN THE CORPORATE LIMITS THEREOF.

1 BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF REDMOND
2 AS FOLLOWS:

3 WHEREAS, there was heretofore and timely filed with the
4 Town Clerk of the Town of Redmond a petition for annexation ad-
5 dressed to the Mayor and Council of the Town of Redmond, and
6 signed by the owners of more than 75 per cent in value, according
7 to the assessed valuation for general taxation of property, of
8 the hereinafter described area and territory seeking to incorpor-
9 ate the said area within the corporate limits of the Town of Red-
10 mond, and make the same part of the said Town; and

11 WHEREAS, thereafter and on the 11th day of July, 1956, the
12 Council by appropriate action adopted a resolution setting forth
13 the above recited facts, and fixed Wednesday, the 25th day of
14 July, 1956, at the hour of 8:00 o'clock P.M., and the Council
15 Chambers in the Town of Redmond, as the time and place for a
16 public hearing upon the petition for annexation of the following
17 described area; and

18 WHEREAS, notice of such hearing was published in the Sammam-
19 ish Valley News, a newspaper of general circulation in the Town
20 of Redmond, and was posted in three public places within the
21 hereinafter described area and territory proposed to be annexed,
22 setting forth the time and place of such hearing; and

23 WHEREAS, on this 25th day of July, 1956, at the hour of
24 8:00 o'clock P.M., the said hearing was held and the Council
25 considered the said petition, and

26 WHEREAS, the Council considers that the best interests of the
27 Town of Redmond, and of the hereinafter described area, would be
28 served by annexing the same to the Town of Redmond; now, therefore,

29 IT IS ORDAINED AND ORDERED, that the following described
30 territory consisting of the following described real estate situ-
31 ated in the County of King and State of Washington, and contig-
uous to the Town of Redmond, be and the same is hereby annexed
to and incorporated into the Town of Redmond, to-wit:

That portion of the southwest quarter of the north-
east quarter of Section 11, Township 25 North, Range 5
East, W.M., lying southerly of the northerly margin of
Drainage District No. 3, northeasterly of State High-
way No. 2D (formerly Clise Road), and northwesterly
of State Aid Road No. 56, (W. W. Easter Road No. 164)
EXCEPT that portion thereof lying northwesterly of
a line which is parallel to and 575 feet northwesterly,
measured at right angles from the northwesterly line
of said State Aid Road No. 56; situated in the County of
King, State of Washington.

BE IT FURTHER ORDAINED: That this Ordinance shall take
effect from and after its passage by the Council and approved by
the Mayor, and after its legal publication as required by law,
and shall thereafter be in full force and effect.
