

ORDINANCE NO. 281

AN ORDINANCE, declaring an emergency in the Water and Sewer Department Fund under the general class Salaries and Wages and providing for an expenditure in excess of the estimated expenditures in said fund and class; providing for the issuance of emergency warrants; and establishing a salary for additional help in the Collector's Office.

WHEREAS, the volume of business in the Collector's Office has increased to a point where the present office help is taxed in its ability to properly handle such business; and

WHEREAS, the City Council finds that an emergency therefore exists in the ability of the City to properly transact its business and that such condition can be corrected by the expenditure of funds in the estimated amount of \$ 2000.00, Now, Therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS:

Section 1 - That an emergency is hereby declared to exist which could not reasonably have been foreseen at the time the estimates were made, requiring an expenditure of \$ 2000.00 money not provided for in said estimates, and the expenditure of \$ 2000.00 is hereby authorized out of the Water and Sewer Department Fund under the general class Salaries and Wages to employ additional help in the Collector's Office in order to provide for said emergency.

Section 2 - Said emergency expenditure shall be paid by the issuance of emergency warrants to be paid from any moneys on hand in the City Treasury in the Water and Sewer Department Fund not otherwise appropriated, or if there be insufficient money on hand in such fund, such warrants shall be registered and shall bear interest at the rate of 5 % per annum until called for and paid.

Section 3 - There is hereby established in the Water and Sewer Department under the general class Salaries and Wages as a part of the Collector's Office two grades of Collector's Office Help. The existing Collector's Office Help shall be known as "Collector's Office Help, Grade 2" and the salary for such position shall be \$1.25 per hour as set in Ordinance No. 268 for "Clerical Help, Part Time." The additional position of "Collector's Office Help, Grade 1" is hereby established by this Ordinance and the salary for such position shall be the sum of \$ 1.75 per hour.

Section 4 - The publication of a copy of this Ordinance in accordance with RCW 35.33.090 prior to its adoption shall constitute publication of the Ordinance under the requirements of RCW 35.24.220, provided no changes have been made in the proposed Ordinance upon its adoption.

Section 5 - This Ordinance shall take effect on April 11, 1962.
