ORDINANCE NO. 331

AN ORDINANCE, annexing certain unincorporated territory in King County, Washington to the City of Redmond pursuant to the results of an annexation election; and fixing the effective date thereof.

WHEREAS, a written Petition for Annexation Election was filed with the City Council on August 27, 1963, requesting that an election be held for the annexation of the territory therein described to the City of Redmond and containing signatures of qualified voters resident in the area in excess of 20% of the vote cast at the last election; and

WHEREAS, the City Council duly adopted Resolution No. 127 on September 10, 1963, approving the proposed annexation election and requiring that there also be submitted to the electorate a proposition for the assumption of the existing indebtedness of the City and causing notice of the action taken be given to petitioners by the publication of said Resolution; and such notice having been duly made; and

WHEREAS, a Review Board was duly convened to consider the proposed annexation and took action deleting portions of the territory proposed for annexation and approving the proposed annexation of the remaining territory as being in the public interest; and

WHEREAS, the Petition for Annexation Election and the findings of the Review Board were duly transmitted to and filed with the Board of County Commissioners for King County, Washington; and

WHEREAS, said Board of County Commissioners duly held a public hearing on the proposed annexation pursuant to law and adopted Resolution No. 27123, fixing February 18, 1964 as the date for a special election to be held within the area upon the annexation propositions; and such election having been duly held; and

WHEREAS, the returns of such election have been duly canvassed and reported and said Board of County Commissioners duly adopted Resolution No. 27435 on February 24, 1964, finding that the proposition for annexation and the proposition for assumption of indebtedness both carried by the required majorities and percentages; and

WHEREAS, said Resolution No. 27435 has been duly certified, transmitted and filed with the City Clerk, together with a certified abstract of the vote, as required by law, and has been transmitted and filed with the City Council; and

WHEREAS, the City Council finds that it is necessary for the immediate preservation of the public peace, health and safety and in furtherance of the public interest that the annexation take effect prior to March 1, 1964, and that an emergency therefor exists; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS:

Section 1. The following described territory is hereby declared to be annexed to the City of Redmond, Washington, such territory being situated in King County, State of Washington, bounded and described as follows:

Beginning at the southeast corner of the southwest quarter of the southeast quarter of section 14, township 25 north, range 5 east, W.M; thence north, along the east line of said subdivision, to the northeast corner thereof; thence westerly, along the north line of said subdivision, to the northwest corner thereof (intersection of the north-south centerline of said section 14); thence northerly, along said centerline, to the east-west centerline of said section, thence westerly, along said east-west centerline of section 14, to the west margin of 156th Avenue N.E., thence northerly along said west margin, to the north right-of-way margin of 51st Street; thence northeasterly, along said north margin, to an intersection with the northeasterly right-of-way margin of the Bellevue-Redmond Road; thence southeasterly, along said northeasterly margin, to an intersection with the east-west centerline of Section 13, Township 25 North, Range 5 East, W.M.; thence easterly, along said east-west centerline to the center of said section 13; thence northerly, along the north-south centerline of said Section 13, to an intersection with the centerline of the Sammanish River; thence southerly, along the centerline of the Sam-mamish River and the centerline of Lake Sammamish, to an intersection with the south line of the north one-quarter of Section 30, Township 25 North, Range 6 East, W.M., prolonged easterly; thence westerly, along said prolonged south line, and said south line, to the westerly line of said Section 30; thence continuing westerly, along the south line of the north half of the northeast quarter of Section 25, Township 25 North, Range 5 East, W.M., to the north-south centerline of said Section 25; thence northerly, along said north-south centerline, to the north line, of said Section 25; thence continuing northerly, along the north-south centerline of Section 24, Township 25 North, Range 5 East, W.M., to an intersection with the south right-of-way margin of N.E. 40th Street; thence westerly, along said south margin, to an intersection with a line, said line being a southerly prolongation of the east line of the southwest quarter of the southeast quarter of said Section 14; thence northerly, along said prolonged line, to the point of beginning.

Section 2. The properties within the area so annexed shall be assessed and taxed at the same rate and on the same basis as the property within the City of Redmond is assessed and taxed to pay for the outstanding indebtedness of the City of Redmond contracted prior to or existing at the date of annexation and thereafter enacted.

Section 3. The effective date of this Ordinance shall be February 27, 1964, and the territory so annexed shall become a part of the City of Redmond as of such effective date, the City Council finding that an emergency exists requiring that the annexation take effect immediately upon the publication of this Ordinance.

Section 4. The City Clerk shall prepare certified copies of this Ordinance and file the same with the Board of County Commissioners of King County, Washington, and shall obtain and file, in duplicate, with the State Census Board the required certificates determining the population of the annexed area.
