ORDINANCE NO. 347 AN ORDINANCE, relating to sewer districts and sanitary sewer service; assuming jurisdiction and control of those portions of Lake Hills Sewer District of King County which are located within the territory annexed to the City of Redmond under Ordinance No. 331; and assuming exclusive jurisdiction over sanitary sewer service within such area. WHEREAS, portions of the boundaries and area of Lake Hills Sewer District of King County, being less than sixty percent (60%) of the area of the district and less than sixty percent (60%) of the assessed valuation of the real property within the district, extend into and are located within the territory recently annexed to the City of Redmond under Ordinance No. 331; WHEREAS, Lake Hills Sewer District of King County presently owns and operates certain sanitary sewerage trunk lines within the City boundaries, which trunk lines serve and transmit sanitary sewerage from areas outside the City boundaries to the sanitary sewage treatment plant on West Lake Sammamish Parkway North, operated by the Municipality of Metropolitan Seattle and known as the Lake Hills Plant," and except for one service connection to Samavillas, Inc. through facilities constructed at the expense of the property owner and involving no bonded indebtedness of the District, the said District has established no sanitary sewerage connection facilities or service within such territory; and WHEREAS, the City Council of the City of Redmond have determined that the assumption of jurisdiction and control over those portions of the Lake Hills Sewer District of King County which are located within the territory annexed to the City of Redmond under Ordinance No. 331 is in the public interest and should be accomplished under the authority vested in the City under Section 22, Chapter 282, Laws of 1961, as amended by Section 1, Chapter 231, Laws of 1963, and Section 23, Chapter 282, Laws of 1961, as amended by Section 2, Chapter 231, Laws of 1963 (RCW 35.13.243 and RCW 35.13.246), NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS: The City of Redmond does hereby assume full jurisdiction and control of those portions of Lake Hills Sewer District of King County which are located within the territory described in and annexed to the City of Redmond under Ordinance No. 331 and the City of Redmond does hereby assume exclusive jurisdiction, dominion and control over sanitary sewer service within the area. The City of Redmond does hereby assume jurisdiction Section 2. of the property, facilities and equipment which is presently serving sanitary sewerage connections within such territory now owned or controlled by the District and which does not involve any bonded indebtedness on the part of the District; Provided, that the District is hereby authorized and is granted the right to continue to operate and own the presently existing sewer trunk lines transmitting and conducting sanitary sewerage from areas outside the boundaries of the City of Redmond so long as such lines shall be reasonably necessary for such purposes, together with the continuing right of maintenance and repair of such trunk lines. -1-347

Section 3. Laws relating to municipal sanitary sewerage utilities and all ordinances, rules and regulations of the City of Redmond relating to sanitary sewerage service and systems shall immediately extend to and be effective within the annexed portions of such territory.

Section 4. This Ordinance shall take effect five (5) days after the date of its publication in the manner provided by law.
