

Cougar Mtn. Et Al Annexation
No. 67-3 (Amendment)

ORDINANCE NO. 428

AN ORDINANCE, relating to the annexation of certain territory under Annexation No. 67-3; and amending Sec. 1, Ordinance No. 421 to clarify the legal description thereof.

WHEREAS, Ordinance No. 421 was duly passed by the City Council and approved by the Mayor on February 28, 1967, annexing certain territory to the City of Redmond under Annexation No. 67-3; and

WHEREAS, it has been determined that the legal description of said territory so annexed should be clarified in order to avoid any confusion or uncertainty, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS:

Section 1. The legal description, as contained in Section 1. of Ordinance No. 421, adopted February 28, 1967, is hereby clarified and corrected, and said Section 1. is hereby amended to read as follows:

"Section 1. The following described territory, situated in King County, State of Washington, is hereby annexed to the City of Redmond, Washington, to wit:

Beginning at the southwest corner of the northeast quarter of Section 35, Township 26 North, Range 5 East, W.M., said point being on the existing City limits of the City of Redmond as established by Ordinance No. 328;

THENCE northerly, along the west line of said northeast quarter of Section 35, to the north line of the south quarter of said northeast quarter of Section 35;

THENCE easterly, along the north line of said south quarter of the northeast quarter of Section 35, to the east line of said Section 35;

THENCE southerly, along the east line of said Section 35, to the northeast corner of the southeast quarter of said Section 35, said point being on the existing City limits of the City of Redmond as established by Ordinance No. 204;

THENCE southerly, along said City limits, to an intersection with the City limits as established by Ordinance No. 243;

THENCE generally westerly, along said City limits, to an intersection with the City limits as established by Ordinance No. 328;


THENCE generally northerly and westerly, along said City limits to the point of beginning."

Section 2. All other provisions, terms and conditions of Ordinance No. 421, except as expressly modified and amended hereby, shall be and remain in full force and effect.

Section 3. This ordinance shall take effect and be in force five (5) days after the date of its publication in the manner provided by law. The City Clerk shall file certified copies of this ordinance with the Board of County Commissioners, King County, State of Washington.

PASSED by the Council of the City of Redmond, Washington, at a regular meeting thereof, and APPROVED by the Mayor this 28th day of March, 1967.
