CITY OF REDMOND, WASHINGTON

ORDÍNANCE NO. 443

AN ORDINANCE, relating to plumbing and plumbing systems including lawn sprinkler systems; adopting a Plumbing Code for the City of Redmond; requiring licenses and permits; prescribing fees; providing penalties for violations; and repealing Ordinance No. 115, adopted June 16, 1948.

THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS:

Section 1. Adoption of Plumbing Code. There is hereby adopted by the City of Redmond, for the purpose of establishing rules and regulations for the construction, alteration, repair, maintenance and operation of plumbing and plumbing systems including lawn sprinkler systems, and their incidents, that certain document and code known as the Plumbing Code adopted by the City of Seattle by its Ordinance No. 92190, as amended by its Ordinance No. 95168, three (3) copies of which have been filed and shall be kept on file with the City Clerk, and the same is hereby adopted by this reference thereto and incorporated herein as fully as though set out in length herein, except such portions as may be deleted, modified or amended by this ordinance; and from the effective date of this ordinance, the provisions thereof shall be controlling within the limits of the City of Redmond.

Section 2.

2. <u>Definitions; Titles of Officials Modified.</u>
(a) Wherever the word "City" is used in the Plumbing Code,

the same shall mean the City of Redmond.

(b) Wherever the title "Director of Public Health" is used in the Plumbing Code to designate the enforcing official, the same shall be changed and modified to mean the Director of Public Works

of the City of Redmond.

(c) Wherever the title "City Comptroller" is used in the Plumbing Code, the same shall be changed and modified to mean the City Clerk of the City of Redmond.

Section 3. <u>Deletions</u>. The following sections of the Plumbing Code are hereby deleted:
Section 5.01.320 (Plumbing Advisory Board)
Section 5.01.380 (Examinations)

Section 5.01.390 (License Fees)

Section 5.01.400 (Revocation of Licenses) Section 5.01.410 (Existing Licenses) Section 5.01.420 (Unlawful Advertising)

Section 5.12.010 (Repeal)

Section 5.12.030 (Penalty)

Section 4. Amendments. The following sections of the Plumbing Code are hereby amended to read as follows:

Section 5.01.360 Contractor's License. It is unlawful to act as a plumbing contractor without a plumbing contractor's license or as a lawn sprinkler contractor without a lawn sprinkler contractor's license. Applications for such licenses shall be made to the Public Works Director, who may inquire into and examine the applicant's qualifications and may require that the applicant apply for and obtain a license by the City of

Seattle or King County as the necessary qualification to act or to obtain a license in the City of Redmond. Provided, That a plumbing contractor or lawn sprinkler contractor who is licensed by the City of Seattle or King County and holds a valid license therefore, may act within the City of Redmond without any further license required; and the Public Works Director may accept such contractor's licenses issued by other municipalities or appropriate governmental authority without further requirement in his discretion and judgment.

Section 5. Repeal. Ordinance No. 115, adopted June 16, 1948, is hereby repealed.

Section 6. Penalties for Violations. Anyone violating or failing to comply with any of the provisions of the Plumbing Code as hereby adopted shall, upon conviction thereof, be punished by a fine not exceeding \$500.00, or by imprisonment in jail for a term not exceeding six (6) months, or by both such fine and imprisonment, and each day that anyone shall continue to so violate or fail to comply shall be considered a separate offense.

Section 7. Effective Date. This ordinance and the code hereby adopted shall take effect and be in force five (5) days after the date of the publication of this ordinance in the manner provided by law.
