ordinance no. 465

AN ORDINANCE, repealing certain prior ordinances in their entirety and specific sections of other ordinances.

THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS:

- Section 1. Repeal. The following ordinances and sections of ordinances are hereby specifically repealed in their entirety:
 - Ordinance 1, licensing the sale of spirituous liquor, passed January, 1913;
 - Ordinance 6, providing for presentation of demands and issuance of warrants, passed January 15, 1913;
 - Ordinance 10, amending Ordinance 2 (council meeting times), passed March 5, 1913;
 - Ordinance 11, relating to traffic, passed March 5, 1913;
 - Sections 1, 2, 3, 4 and 8 of Ordinance 12, regulating traffic in intoxicating and malt liquor, passed March 5, 1913;
 - Ordinance 13, providing method of assessing and collecting taxes, passed May 7, 1913;
 - Ordinance 17, amending Ordinance 2 (council meeting times), passed March 4, 1914;
 - Ordinance 18, establishing water rates, passed November 4, 1914;
 - Ordinance 19, amending Ordinance 1 (licensing liquor sales), passed December 23, 1913;
 - Ordinance 21, prohibiting minors from playing certain games or loitering about pool and billiard rooms and bowling alleys, passed July 4, 1915;

- Ordinance 71, relating to sale and consumption of liquor, passed December 6, 1933;
- Ordinance 73, amending Ordinance 35 (water rates), passed April 4, 1934;
- Ordinance 93, bond for town marshal, passed July 5, 1945;
- Ordinance 98, regulating and controlling use and occupation of streets, sidewalks, alleys and public places, passed February 13, 1946;
- Ordinance 112, creating planning commission, passed May 5, 1948;
- Ordinance 116, amending Ordinance 112 (planning commission), passed July 7, 1948;
- Ordinance 134, nominating candidates for town office, passed January 18, 1950;
