

CITY OF REDMOND, WASHINGTON

ORDINANCE NO. 478

AN ORDINANCE of the City of Redmond, authorizing the execution of a contract with King County, providing for the receipt and application of a portion of the proceeds of certain general obligation bonds of the County and designating the King County Design Commission to serve as the design commission of the City for projects acquired or constructed with said proceeds.

WHEREAS, King County, Washington, has been authorized by the voters of the County to issue its General Obligation Bonds in the principal amount of not to exceed \$ 118,000,000. in series from time to time to provide funds to pay the cost of acquisition and development of public park and recreation facilities in the County including facilities within the City; and

WHEREAS, Resolution No. 34571 of the Board of County Commissioners provides that certain park and recreation facilities shall be acquired and/or developed by the several cities in the County and requires that each such city shall first enter into an agreement with the County that the proceeds shall be faithfully applied to the purposes authorized by such resolution; and

WHEREAS, it is in the best interests of the City of Redmond and the residents thereof and necessary for the public health, welfare and safety that the City accomplish the Park and recreation

purposes set forth in said Resolution No. 34571 to be performed by the City and that the City enter into such agreement and take such other action as may be reasonably necessary to comply with the terms and conditions of such agreement; Now, Therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS:

Section 1. The City of Redmond shall enter into an agreement with King County substantially in the form of Exhibit A attached hereto and by this reference made a part hereof, and the Mayor and City Clerk are authorized to execute said agreement for and on behalf of the City.

Section 2. The appropriate officers and agents of the City of


Redmond are hereby authorized and directed to do all things necessary to accomplish the development of park and recreation facilities for which moneys shall become available pursuant to the agreement authorized by this ordinance.

Section 3. The King County Design Commission is hereby authorized to act for and on behalf of the City of Redmond to recommend the selection of members of the design team to be employed by the City for the planning and design of any structures or surface development work to be accomplished by the City with the funds provided from the sale of bonds issued pursuant to Resolution No. 34571 of King County and to review the plans and specifications for such structures or work. The project shall reimburse the county's actual cost attributed to the project. Provided, That the authorization hereinabove given to the King County Design Commission shall continue until such time as the City of Redmond may hereafter create its own Design Commission as authorized under the Forward Thrust Program (King County Resolution Nos. 34571 and 34569).

Section 4. This ordinance shall take effect and be in force five (5) days after the date of its publication in the manner provided by law.

PASSED by the Council of the City of Redmond, Washington, at a regular meeting thereof, and APPROVED by the Mayor this 5th day of November, 1968.

EXHIBIT A

A G R E E M E N T

For and in consideration of the mutual covenants herein, King County, hereinafter called "County," and the City of Redmond, hereinafter called "City," agree as follows:

1. The County shall deliver to the City in the ordinary course of business after receipt of the proceeds of each series of general obligation bonds of the County contemplated to be issued pursuant to Resolution No. 34571 of the County, the full amount of cash allocated to the City out of such proceeds by said Resolution.

2. The City shall faithfully hold and apply said money to the purposes authorized in said Resolution No. 34571 and Resolution No. 35555 in the manner and subject to the conditions provided in said resolutions; shall operate and maintain all facilities acquired, constructed, developed or improved with said money; shall defend and save the County harmless from any claim of damage resulting from the acquisition, construction, development, improvement, operation, maintenance, repair, replacement or public use of such facilities; and shall perform or comply with all conditions of said resolutions contemplated therein to be performed or complied with by agencies to which the proceeds of bonds issued pursuant to such resolutions have been allocated and delivered.
