

CITY OF REDMOND, WASHINGTON

ORDINANCE NO. 531

AN ORDINANCE, establishing and designating offices, positions and ranks in the Redmond Police Department for the purpose of determining eligibility for the Washington Law Enforcement Officers' and Fire Fighters' Retirement System.

WHEREAS, the City of Redmond has heretofore established, operated and maintained a full time, paid police department, with the personnel and positions of such department covered by a classified civil service pursuant to RCW 41.12 and Chapter 2.12 of the Redmond Municipal Code (Ord. 403), and with the offices, positions and ranks heretofore established by Ordinance 510 and previous salary ordinances of the City; and

WHEREAS, the Washington Law Enforcement Officers' and Fire Fighters' Retirement System Act, enacted by Ch. 209, Laws of 1969 (1st Ex. Sess.), as amended by Ch. 6, Laws of 1970 (1st Ex. Sess.), codified as RCW 41.26, provides that the term "city police officer" shall only include regular, full time personnel of the city police department as have been appointed to offices, positions or ranks in the department which have been specifically created or otherwise expressly provided for and designated by ordinance enacted by the legislative body of the city, NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS:

Section 1. Offices, positions and ranks of police department. The following offices, positions and ranks are hereby created, established and designated for the Police Department of the City of Redmond: Chief of Police, Assistant Chief, Captain, Lieutenant, Sergeant, Detective, Patrolman, and Policewoman, including all grades and ranks therein as may be designated by the Civil Service

Commission. Such offices, positions and ranks shall be filled by appointment in accordance with Chapter 2.12 of the Redmond Municipal Code, as provision is made therefor in the budget and compensation ordinances enacted by the City Council, and shall constitute regular full time personnel of the city police department.

Section 2. Eligibility for pension and retirement coverage.

Certification by the Mayor that a regular, full time employee of the Redmond Police Department has been duly appointed and commissioned to a position, office or rank in the Department as created and established by ordinance of the City Council, shall constitute such employee as being eligible for coverage in the Washington Law Enforcement Officers' and Fire Fighters' Retirement System, as a "city police officer" as such term is defined in RCW 41.26.


Section 3. Previous coverage. The positions, offices and ranks established and designated in Ordinance 510, passed December 16, 1969, for the appointed Police Chief and Police Department, excluding "Radio Operator - Dispatcher," are hereby ratified and confirmed to be the positions, offices and ranks of the Redmond Police Department, effective as of January 1, 1970 (the effective date of said ordinance), for the purposes of determining membership eligibility of city police officers in the Washington Law Enforcement Officers' and Fire Fighters Retirement System under RCW 41.26.

Section 4. Effective Date. This ordinance shall take effect and be in force five (5) days after the date of its publication in the manner provided by law.




