CITY OF REDMOND, WASHINGTON ordinance no. 6/3 AN ORDINANCE, establishing rules and regulations for the use of public parks within the City of Redmond; and prescribing penalties for violations. THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS: Rules and regulations established for park use. The following rules and regulations are hereby established for the use of public parks and facilities within the City of Redmond: (a) Applicants scheduling a facility for daily, weekly, monthly or seasonal activities must complete an application form which will be submitted to the Park Department for approval. Applicants should understand that public recreation facilities that are organized for the general public, or those actively co-sponsored by the Department, have priority over other groups in the scheduling of a facility. In addition to completing an application form prior to using park facilities, organized groups shall agree to hold the City of Redmond harmless from any and all claims for damages, injuries, or loss of property that may result from any act or omission of the applicant or his agents while on City of Redmond property. Drinking and/or possession of intoxicants or drugs in park buildings or on park grounds is prohibited. (d) Except as may be authorized by the Park Director or his designee in writing, park facilities shall be open from 6:00 A.M. to 10:00 P.M., daily, otherwise to be closed, and lighted athletic facilities will be shut off at 11:00 P.M. No overnight camping, camp fires, motorized vehicles, or horses shall be allowed on any park grounds except in designated areas or as previously authorized in writing by the Park Director or his designee. Dogs must be on leash at all times. Altering or defacing any buildings, playground equipment, flora, fauna, or any other park property in any way is prohibited. Firearms and any other dangerous weapons are prohibited (g) on park grounds except by authorized person. (h) All groups must leave the park facility in a condition considered satisfactory to the park supervisor. For activities requiring a specific service, clean-up, and/or supervision, the applicant will be charged a reasonable fee for the use of the recreation facility in accordance with a current fee schedule issued by the Park Director. The misuse of any park or recreation facility or the failure to conform with these regulations will be sufficient cause to deny any future use by the applicant. Section 2. Penalty for violations. The violation of any of the rules and regulations set forth under Section 1 shall be classed as a misdemeanor under Section 1.01.110 of the Redmond Municipal Code and shall be subject to a penalty not exceeding \$500.00 maximum fine and/or 6 months in jail. Section 3. Effective date. This ordinance shall take effect and be in force five (5) days after the date of its publication in the manner provided by law.
