ORDINANCE NO. 706

AN ORDINANCE, relating to salaries and wages, establishing salaries and wages for certain officials and employees; adopting supplements to the Wage and Classification Plan contained in the Personnel Administration Manual, 1974 Edition; and repealing Ordinance No. 678.

THE CITY COUNCIL OF THE CITY OF REDMOND DO ORDAIN AS FOLLOWS:

Section 1. Elected and appointed officials. The following salaries and wages are hereby established for those offices, departments and positions of officials and employees of the City of Redmond for the pay period beginning January 1, 1976:

Section 4. Effective date. This ordinance shall take effect and be in force five (5) days after its publication in the manner provided by law. The salaries and wages provided in the supplements to the Wage

and Classification Plan referred to in Section 1 shall take effect and be in force from and after January 1, 1976.
