ORDINANCE NO. 937

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, IMPOSING PARKING RESTRICTIONS ON PORTIONS OF AVONDALE ROAD, AVONDALE WAY, OLD REDMOND ROAD AND WEST LAKE SAMMAMISH PARKWAY; AUTHORIZING APPROPRIATE SIGNS TO BE ERECTED; SUPPLEMENTING A SCHEDULE OF PARKING RESTRICTIONS CONTAINED IN SECTION 10.52.180 OF THE REDMOND MUNICIPAL CODE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council, based upon the recommendation of the Director of Public Works, has determined there is a need to restrict parking in certain areas within the City identified hereinafter, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The schedule of parking restrictions adopted by Section 10.52.180 of the Redmond Municipal Code is hereby supplemented by adding the following streets or portions of streets to said schedule with the parking restriction as indicated:

Avondale Rd.	West Side	NE 104th St.	Redmond Way (SR 202)	No Parking Anytime
Avondale Way	West Side	Avondale Rd.	Union Hill Rd	No Parking Anytime
Old Redmond Rd	South Side	148th Avenue N.E.	146th Avenue N.E.	No Parking, Stopping or Standing
West Lake Samm. Way	East Side	Bel-Red Rd.	N.E. 51st St	No Parking Anytime

Section 2. The Director of Public Works is hereby authorized and instructed to cause appropriate signs to be erected upon such streets giving notice of the limitations or prohibitions of parking thereon.

Section 3. This ordinance shall be in full force and effect five (5) days after its passage and publication as provided by law.
