ORDINANCE NO. 944

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING SECTION 10.24.060 OF THE REDMOND MUNICIPAL CODE TO REVISE THE SPEED LIMIT FOR A PORTION OF WEST LAKE SAMMAMISH PARKWAY (SR 901) AND A PORTION OF UNION HILL ROAD WITHIN THE CITY.

WHEREAS, based upon the results of engineering and traffic investigation, the City Traffic Engineer has recommended that the speed limit applicable to certain roadways within the City be revised, and

WHEREAS, based upon the recommendations of the Traffic Engineer, the City Council has determined that the speed limit provisions instituted by this ordinance will result in the establishment of safe and reasonable speed limits, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Section 10.24.060 of the Redmond Municipal Code is hereby amended to read as follows:

"10.24.060 SCHEDULE

The maximum speed limits set forth in the following schedule of speed limits are hereby established as the reasonable and safe maximum speed limits to be effective at all times upon the streets and highways designated in said schedule. The traffic engineer, in conjunction with state highway authorities, shall cause appropriate signs to be erected on such streets and highways giving notice of such speed limits, as provided in Section 10.24.050."

Section 2. That portion of the schedule of speed limits set forth in Section 10.24.060 of the Redmond Municipal Code which establishes the maximum speed limit for all traffic on both sides of West Lake Sammamish Parkway (SR 901) from Bellevue-Redmond Road to the south city limits (North-east 20th Street) is hereby revised by reducing the maximum speed limit to 35 miles per hour, subject to concurrence by the State of Washington.

Section 3. The schedule of speed limits set forth in Section 10.24.060 of the Redmond Municipal Code is hereby supplemented by adding a maximum speed limit of 35 miles per hour for all traffic on both sides of Union Hill Road from Avondale Road to the east city limits (196th Avenue N.E.).

Section 4. The Traffic Engineer is hereby directed to post signs in accordance with Section 10.24.050 of the Redmond Municipal Code giving notice of the speed limits established by this ordinance after the effective date of this ordinance and concurrence of the State of Washington, if such concurrence is required.

Section 5. This ordinance shall be in full force and effect five (5) days after its passage and publication as provided by law.
