ORDINANCE NO. 983

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, SUPPLEMENTING THE 1981 BUDGET ADOPTED BY ORDINANCE NO. 955, PASSED BY THE CITY COUNCIL ON DECEMBER 16, 1980, TO APPROPRIATE UNANTICIPATED REVENUES FROM THE FEDERAL REVENUE SHARING PROGRAM; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, at the time of adoption of the 1981 Budget, the amounts of revenues to be collected from various sources could only be estimated, resulting in the need to supplement the budget to provide for unanticipated revenues, and

WHEREAS, the funds actually received through the Federal Revenue Sharing Program exceeded anticipated revenues by the amount of \$45,500, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The final budget for the fiscal year 1981, as adopted by Ordinance No. 955, passed by the City Council on December 16, 1980, is hereby supplemented and amended by increasing the revenues to the Revenue Sharing Fund No. 199 by the sum of \$45,500 and increasing the appropriations from said fund in the amount of \$43,500, which appropriations consist of the following:

Additional work stations for Parks, Personnel Office and Comptroller's Office	5,000
Milfoil Program	9,000

Section 2. Section 2 of Ordinance No. 955, passed by the City Council on December 16, 1980, is hereby amended by revising the summary of totals of estimated revenues and appropriations incorporated in said section as Exhibit "A" to reflect the increase of revenues to Revenue Sharing Fund

No. 199 in the amount of \$45,500 and the increase in the amount of expenditures chargeable to said fund in the amount of \$43,500.

Section 3. The Treasurer/Comptroller is hereby authorized and instructed to effectuate the necessary changes to the 1981 Budget and to make all necessary and appropriate line item entries and adjustments in order to reflect the increases to revenues and appropriations as set forth in this ordinance.

Section 4. This ordinance shall be in full force and effect five (5) days after passage and publication by posting as provided by law.


