

ORDINANCE NO. 987

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, SUPPLEMENTING AND AMENDING THE 1981 BUDGET ADOPTED BY ORDINANCE NO. 955, PASSED BY THE CITY COUNCIL ON DECEMBER 16, 1980, TO PROVIDE FOR THE APPROPRIATION OF UNANTICIPATED REVENUES, TO PROVIDE FUNDING FOR COMPLETION OF THE JOINT LAND USE STUDY FOR THE COUNTY AREA NORTH OF THE BELLEVUE-REDMOND ROAD; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, at the time of adoption of the 1981 Budget, the amounts of revenues to be collected from various sources can only be estimated, resulting in the need to supplement the Budget to provide for appropriation of unanticipated revenues, and

WHEREAS, the City has received funds over and above its estimate for interest earnings and needs additional funds to complete the joint land use study between King County, the City of Bellevue, and the City of Redmond for that area of King County lying northerly of the Bellevue-Redmond Road, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The final Budget for the fiscal year 1981, as adopted by Ordinance No. 955, passed by the City Council on December 16, 1980, as amended by Ordinance No. 983, passed on May 19, 1981, is hereby further supplemented and amended by increasing the revenues to the General Fund 001 by the sum of \$13,000 from unanticipated interest income and increasing the appropriations from the General Fund to the Planning Department for the purpose of completing funding of Redmond's share of the joint Bellevue-Redmond Road land use study in the amount of \$13,000, representing an \$8,000 1980 appropriation that lapsed and an additional \$5,000 required to complete the study over and above the previous estimates.

Section 2. Section 2 of Ordinance No. 955, passed by the City Council on December 16, 1980, as amended by Ordinance No. 983, passed by the City Council on May 19, 1981, is hereby further amended by revising the summary of totals of estimated revenues and appropriations incorporated in said Section as Exhibit A to reflect the increase of revenues to General Fund 001 in the amount of \$13,000 and the increase in the amount of appropriations from said fund in the amount of \$13,000.

Section 3. The Treasurer/Comptroller is hereby authorized and instructed to effectuate the necessary changes to the 1981 Budget and to make all necessary and appropriate line item entries and adjustments in order to reflect the increases to revenues and appropriations as set forth in this Ordinance.

Section 4. This Ordinance shall be in full force and effect five (5) days after passage and publication by posting as provided by law.


