

ORDINANCE NO. 994

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE 1981 BUDGET ADOPTED BY ORDINANCE NO. 955, PASSED BY THE CITY COUNCIL ON DECEMBER 16, 1980, TO ALLOCATE AND REALLOCATE REVENUE SHARING FUNDS TO PROVIDE FUNDING FOR ACQUISITION OF EQUIPMENT BY THE FIRE DEPARTMENT, THE FINANCIAL ANALYSIS PORTION OF THE GROWTH MANAGEMENT PROGRAM, AND FOR A NEEDS ASSESSMENT STUDY OF CITY FACILITIES AND DEPARTMENTS; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, subsequent to adoption of the 1981 Budget, three proposed programs have been presented to the City Council, to wit, the purchase of equipment for the Fire Department to replace obsolete equipment, completion of the Planning Department Growth Management Report by addition of a comprehensive financial analysis, and preparation of a needs assessment of City facilities and departments, and the City Council has determined that these proposed programs should be carried out, and

WHEREAS, no provision was made in the 1981 Budget to fund these programs, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The final Budget for the fiscal year 1981, as adopted by Ordinance 955, passed by the City Council on December 16, 1980, as amended by Ordinance No. 983, passed on May 19, 1981, and further amended by Ordinance No. 987, passed on July 7, 1981, is hereby further amended by reallocating the sum of \$91,000 and allocating the sum of \$2,000.00 heretofore unallocated, by way of an intrafund transfer within Revenue Sharing Fund Number 199 as follows:

At the special meeting of September 8, 1981, the Council provided authorization for reallocation of \$93,000 of Revenue Sharing.

The attached ordinance (as available) provides for reallocating \$86,500 from old fire hall improvement, \$4,500 from the milfoil program and \$2,000 unappropriated funds to be used as follows:

- \$87,500 for Fire Department equipment
- \$4,000 for Growth Management fiscal analysis
- \$1,500 for Facilities Needs Assessment.
