A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, SETTING MARCH 1, 2016, AS THE DATE FOR A PUBLIC HEARING ON THE VACATION OF A PORTION OF 180TH PLACE NE RIGHT-OF-WAY LYING SOUTH OF NE 65TH STREET AND WEST OF EAST LAKE SAMMAMISH PARKWAY NE (MARYMOOR APARTMENT PROJECT)

WHEREAS, a petition as depicted in Exhibit C has been submitted requesting the vacation of a portion of 180th Place NE right-of-way lying south of NE 65th Street and west of East Lake Sammamish Parkway NE; and

WHEREAS, the petition was signed by the owners of one hundred percent of the property abutting on the portion of the right-of-way sought to be vacated; and

WHEREAS, pursuant to RCW 35.79.010, the Redmond City Council is required to set the date for a public hearing on the requested vacation.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Hearing. Pursuant to RCW 35.79.010, a public hearing is hereby set before the Redmond City Council for March 1, 2016, at 7:30 p.m., or as soon thereafter as the matter may be heard, in order to receive public testimony and consider the proposed vacation of a portion of 180th Place NE right-of-way lying south of NE 65th Street and west of East Lake Sammamish

Parkway NE, as legally described in Exhibit A and depicted in Exhibit B, both of which are attached hereto and incorporated herein by this reference as if fully set forth. The hearing will be held in the City Council Chambers of Redmond City Hall, 15670 NE 85th Street, Redmond, Washington.

Section 2. Notice. The Planning Department is hereby directed to post written notice of the hearing in three of the most public places in the City and in a conspicuous place upon the area proposed for vacation. Such notice shall be posted at least twenty (20) days in advance of the hearing. The notice shall contain a statement that a petition has been filed to vacate that portion of 180th Place NE right-of-way lying south of NE 65th Street and west of East Lake Sammamish Parkway NE. The notice shall also contain a statement of the time and place fixed for the hearing.




