CITY OF REDMOND RESOLUTION NO. 1448

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, AFFIRMING COMPLETION OF REDMOND'S PERIODIC REVIEW UPDATE, AS NEEDED, OF DEVELOPMENT COMPREHENSIVE PLAN AND COMPLIANCE REGULATIONS ΙN WITH RCW 36.70.A.130 AND RELATED PROVISIONS

WHEREAS, the Growth Management Act (GMA), in RCW 36.70A.130, requires that counties and cities take action to review, and if needed, revise their comprehensive plans and development regulations to ensure that the plan and regulations comply with the requirements of the GMA; and

WHEREAS, the City of Redmond conducted a public scoping process starting in January 2010 to invite public comment on what issues should be addressed as part of the periodic review and update; and

WHEREAS, the City of Redmond has reviewed its Comprehensive Plan and development regulations for consistency with the GMA and regional plans, as well as changed conditions since the last update; and

WHEREAS, on February 27, 2010, the Planning Commission held a public hearing to seek public input on the proposed scope for Redmond's periodic review and update; and

WHEREAS, on April 20, 2010, the City Council adopted Resolution No. 1326, which established the general scope and schedule for Redmond's 2010-11 Comprehensive Plan Periodic Review and Update which included updating Redmond's growth targets to 2030 to accommodate projected growth consistent with Redmond's land use capacity; and

WHEREAS, the City of Redmond established and broadly distributed to the public information about how to participate in the periodic review and update starting in January 2010 and throughout the periodic review and update process, consistent with RCW 36.70A.130(2), RCW 36.70A.035 and RCW 3670A.140; and

WHEREAS, notices for all proposed amendments to Redmond's Comprehensive Plan and development regulations were sent to state agencies at least 60 days before the amendments were adopted; and

WHEREAS, the City issued State Environmental Policy Act (SEPA) Addendums to the Final Environmental Impact Statement for the City of Redmond Comprehensive Plan on November 18, 2011 and March 19, 2013 for the Comprehensive Plan and Transportation Master Plan updates and issued SEPA Determinations of Non-Significance for other proposed amendments; and

WHEREAS, between 2010 and 2015 the City of Redmond Planning Commission held study sessions and 17 public hearings and the

City Council deliberated in study sessions as part of Redmond's periodic review and update; and

WHEREAS, the City Council adopted updates to Redmond's Comprehensive Plan and development regulations as part of the periodic review and update with adoption of Ordinance Nos. 2638, 2663, 2639, 2640, 2671, 2703 and 2803; and

WHEREAS, the City of Redmond, during the process of its periodic review and update, has reviewed its Comprehensive Plan and development regulations for consistency with the GMA and identified and adopted needed amendments; and

WHEREAS, the City of Redmond, through Ordinance No. 2638, deferred proposed updates to stormwater policies in the Utilities element for further review and action as part of a future annual amendment package and determined that these updates are not required as part of the periodic review and update; and

WHEREAS, the City of Redmond has regularly updated its critical areas regulations as new scientific information becomes available and as needed for consistency with the GMA.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES that pursuant to RCW 36.70A.130, the City Council affirms that the City has completed its periodic review and revision as needed of its Comprehensive Plan and development regulations.
