RESOLUTION NO. 1458**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY
OF REDMOND, WASHINGTON, AMENDING THE PARKS
AND RECREATION DEPARTMENT USER FEE SCHEDULE
ADOPTED BY RESOLUTION NO. 1072 AND PREVIOUSLY
AMENDED BY RESOLUTION NOS. 1140, 1181, 1201,
1267, AND 1392, AND INCORPORATING SPECIAL
EVENT PERMIT FEES INTO THIS FEE SCHEDULE

WHEREAS, Ordinance No. 1480 of the City of Redmond provides
that all administrative fees will be set by Council resolution;
and

WHEREAS, Resolution No. 1072, passed by the City Council on
June 16, 1998, adopted a comprehensive user fee schedule for the
Parks and Recreation Department; and

WHEREAS, Resolution No. 1140, passed by the City Council on
November 20, 2001; Resolution No. 1181, passed by the City Council
on March 2, 2004; Resolution No. 1201, passed by the City Council
on April 5, 2005; Resolution No. 1267, passed by the City Council
on January 15, 2008; and Resolution No. 1392, passed by the City
Council on September 17, 2013, amended and updated the user fee
schedule; and

WHEREAS, department directors shall annually review the user
fees, charges and penalties in order to determine whether the same
are adequate to cover the City's costs of providing the services
for which the fee, charge, or penalty is collected.


NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Fee Schedule Amended. The Comprehensive User Fee Schedule for the Parks and Recreation Department, as adopted by Resolution No. 1072 of the City Council and as previously amended by Resolutions Nos. 1140, 1181, 1201, 1267, and 1392 is hereby further amended to read as set forth on Exhibit 1 attached hereto and incorporated herein by this reference as if set forth in full, is hereby adopted and approved.

Section 2. Effective Date. This resolution, and the fees adopted herein, shall become effective on January 1, 2017, and for which the fee has not been collected prior to that date.

Commercial Use – Definition

Commercial uses of a facility are those activities that involve advertising, promoting or selling of merchandise and/or services. Commercial fees are also applied to business meetings, seminars or rentals that charge admission fees or tuition, events that are advertised and open to the general public where fees are charged, and events or activities for the purpose of fundraising.

Special Event Expressive Activity – Per RMC 10.62.140

The Parks and Recreation Department Director has the authority to waive or reduce special event permit fees and additional fees for direct City services for special events in which the purpose is First Amendment expression if such fees would constitute an unreasonable burden, economic hardship or inability to pay.
